Terms and Conditions

1. "The Company" means Truckman Limited and applies throughout these terms and conditions.
2. "Warranty Period" means 36 months from date of invoice for Truckman tops for pick-ups.
3. "Dealer" means the vehicle dealer supplying the Truckman Top.
4. In the event of a defect appearing in the goods within the Warranty Period and subject to the defects being properly reported to the Dealer, then the Company will ensure that if the defect is found to be due to faulty materials or workmanship it will be repaired and any necessary replacement parts will be supplied and fitted. Any such work will be carried out absolutely free of charge of any kind whether for labour or materials. However, any charge arising from the delivery of the vehicle to the company or dealer and its subsequent return to the owner will not be paid by the Company.
5. Any parts replaced will be retained by the Company.
6. Parts fitted or repaired under the terms of this Warranty are covered for the remaining part of the original Warranty period.
7. This Warranty does not apply if the goods are subject to:
a. neglect or damage as a result of an accident;
b. improper use, i.e. where the goods have not been used and maintained as recommended by the chassis manufacturer and the Company;
c. defects occurring after the purchaser has allowed another party (unless authorised by the Company) to repair, adjust, alter, modify or otherwise work on the top;
d. defects which are aggravated as a result of continued use after such defects ought to have been repaired;
e. defects occurring as a result of a design where the specification was given by the Purchaser. Any exceptions to the period of Warranty will be noted on the invoice.
8. In the event of a defect the following details should be reported to the Dealer immediately:
1. Nature of defect. **2.** Date of invoice. **3.** Serial No.
